**INVITATION TO BID**

1. The *Provincial Government of South Cotabato*, through the 2020 Continuing Appropriation intends to apply the sum of **₱ 2,998,500.00** being the Approved Budget for the Contract (ABC) to payments under the contract for INF-ITB 20-013-A Construction of Level II Potable Water System at Sitio San Roque, Brgy. Buenavista, Surallah, South Cotabato. Bids receive in excess of the ABC shall be automatically rejected at bid opening.
2. The *Provincial Government of South Cotabato* now invites bids for *Construction of Level II Potable Water System at Sitio San Roque, Brgy. Buenavista, Surallah, South Cotabato*. Completion of the Works is required 120 Calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested Bidders may obtain further information from the *Provincial Government of South Cotabato* and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on March 12 – April 2, 2020 from the Bids and Awards Committee Secretariat at BAC Office, Provincial Capitol Compound, Alunan Avenue, City of Koronadal and upon payment of the applicable fee for the Bidding Documents in the amount of Two Thousand Nine Hundred Ninety Eight Pesos and 50/100 (P 2,998.50).

It may also be downloaded free of charge from the website of the Philippine Electronic Procurement System (PhilGEPS), the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Provincial Government of South Cotabato* will hold a *Pre-Bid Conference on March 19, 2020 at 3:00 p.m.* at the *Bids and Awards Committee (BAC) Office, Provincial Capitol Compound, Alunan Avenue, Koronadal City, South Cotabato*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before April 2, 2020 at 12:00 noon. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on April 2, 2020 at 3:00 p.m. at the BAC Office, Provincial Capitol Compound, Alunan Avenue, City of Koronadal, South Cotabato. Bids will be opened in the presence of bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Provincial Government of South Cotabato* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders
